1. Title of the Position: Director (Project Monitoring and Execution) (On Contract) **No. of Position:** 01 (UR)

Qualification: BE/BTech/ME/MTech (preferably Civil/Mechanical/Electrical) or equivalent **Experience Required:** 25 years, out of which substantial experience should be in technical/engineering services.

Maximum Age: 60 years as on 31/12/2023

Job Description:

- Review that the project is being constructed as per the drawings in line with the scope of the Project Specifications and Standards etc.
- Review Detailed Project Report.
- Verify project progress inline with the bar/gant/pert chart with regard to the planned physical and financial progress of various project components.
- Verify the allocation and spending of various heads and subheads with the approval.
- Verify various POs related by the company with regard to the payment terms.
- Verification of plant, machinery, and equipment delivered/installed/commissioned etc.
- Comment on the value and useful/residual life of used/second hand/refurbished equipment in line with the guidelines.
- The plant & machinery, equipment, etc, for which the fiscal support has been claimed are new or refurbished/used/second hand.
- Comment on the central and state level approvals and adequacy of insurance policies.
- Conducting the physical site inspection of the assigned project to monitor project milestones
 and verify that physical progress commensurate with the financial expenditure. Highlight
 delays in the construction schedule, if any, as well as any corrective action planned by the
 project company.

- Verification of setting up of capacities as detailed in the project appraisal. To comment on any changes in the capacities and corresponding changes in the project cost.
- Comment on the eligible capital expenditure/investment as per the approval letter and scheme guidelines out of the cost/expenditure for which fiscal support has been claimed.
- Comparison of the tool list against the tool list submitted during the appraisal.
- Verifying the cost of construction per square feet/Plinth Area Rates for the claim for the building constructed are in line with prevailing CPWD rates / applicable State PWD rates for items where such rates are applicable. For other items where aforesaid rates are not applicable, the rates are as per market value.

- Those working in Central or State Government/Semi-Govt./ Govt. autonomous bodies/CPSEs/PSUs/PSEs may submit the requisite information without the documents mentioned below. In case the applicant is shortlisted for interview, following information/documents, about the applicant from the current employer should be provided on the date of interview:
- i. No Objection Certificate (NOC) from the current employer stating that <Company Name> has no objection in his/her applying for the post of <Name of Post applied for> in IFCI Ltd and if selected for an appointment to the post applied for by him/her, will be allowed to join his/her new assignment.
- ii. Certificate that the applicant is clear from vigilance angle and no disciplinary proceedings are pending or contemplated against him/her.
- iii. Certificate of Integrity stating that "The Integrity of <Applicant Name> is beyond doubt".
- All Computations of age shall be done considering **December 31, 2023** as the cut-off date.
 The date of declaration of result / issuance of mark sheet shall be deemed to be the date of
 acquiring the qualification and there shall be no relaxation on any of these accounts.
- The mere fact that a candidate has submitted the Resume/Biodata against the advertisement and apparent fulfilling of criteria as prescribed in the advertisement would not bestow on him/ her the right to be called for interview / considered for selection process. IFCI at its discretion

- 4. The total number of projected vacancies/Level offered indicated may increase / decrease / be cancelled at the discretion of IFCI, if need so arises, without any further notice and without assigning any reason thereof.
- The advertised positions are for Head Office, IFCI Ltd located at New Delhi. However, the candidates can be transferred to any of its Regional Offices anywhere in India or Head Office/Subsidiaries / Associates.
- 6. The candidates belonging to SC or ST category, if called for interview physically, will be eligible for reimbursement of Travelling Allowance as per Govt. of India guidelines. If at any stage, it is found that the candidate does not meet the prescribed eligibility criteria, he/she will be disqualified and no to & fro fare will be paid by IFCI.
- 7. Only Indian Nationals are eligible to apply. While applying for any post, the applicant should ensure that he/she fulfils the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. To ascertain eligibility IFCI may obtain additional information from candidate. In case, it is detected at any stage of engagement process, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his/her services are liable to be terminated without any notice.

- 9. IFCI reserves the right to restrict the number of shortlisted candidates for interview on the basis of qualifications and experience higher than the minimum prescribed.
