Information Sought (जानकारी मांगी):	<p>The Family Pension being paid by IFCI to the dependents of its deceased employees under IFCI Pension Regulations, 1993 is calculated taking into account the pay last drawn by the deceased employees before retirement or death, the date of their retirement and date of their death, the pay scale period in which the deceased employees had drawn the last pay and other factors relevant to calculation of the amount of Family Pension. Therefore this information is held by and is under the control of IFCI. Since this information is available in the records or document of IFCI, I seek following information IFCI under RTI Act.</p> <p>(a) Please provide total number of dependents of the deceased employees of IFCI, as on July 31, 2023, whom Family Pension is being paid by IFCI directly or through Life Insurance Corporation of India, under IFCI Pension Regulations, 1993.</p> <p>(b) Out of the total number of dependents of the deceased employees of IFCI, as asked for in (a) above, please provide number of recipients of Family Pension under IFCI Pension Regulations, 1993 in whose cases the amount of Family Pension had been calculated with reference to the pay drawn by the employees of IFCI before retirement or on the date of death, in compliance with Instruction No.2 related to Regulation No.32 of the IFCI Pension Regulations, 1993 as is mentioned in Chapter VI of the</p>		

Memorandum of Instructions for implementation of Pension Scheme under IFCI Pension Regulations, 1993.

(c) Out of the total number of dependents of the deceased employees of IFCI, as asked for in (a) above, please provide the number of dependents of those employees who had retired or died in harness after 01.11.1997 and had drawn pay or pension or both in the pay scales of periods of 01.11.1997 to 31.10.2002 and from 01.11.2002 to 31.10.2007 but in their cases the amount of Family Pension had been calculated with reference to the pay which existed in the pay scale period from 01.11.1992 to 31.10.1997.

(d) The practice followed by IFCI for calculating the amount of Family Pension as mentioned at (c) above has not been found in the IFCI Pension Regulations, 1993 posted on its website. Therefore, as per Section 5(3) of the RTI Act, you are requested to please render me necessary assistance and provide a Certified Hard Copy of the extract from the IFCI Pension Regulations, 1993 or copies of any other Rules, Regulations, or any other policy circular or document which authorizes the officials of IFCI to record noting at the time of processing sanction of Family Pension that in respect of employees retired or died in harness after 01.11.1997, Family Pension and D.A. is calculated on pre-revised pay basis. The pre-revised pay here means the pay that existed in pay scale period of 01.11.1992 to 31.10.1997.
