In other words, I retired after 1.11.1993. Please provide me a Certified hard copy of specific Regulation of the IFCI Pension Regulations, 1993 or the copy of the Instructions for implementation of Pension Scheme under IFCI Pension Regulations 1993 or any other document on which the formula for calculating the rates of DR, applicable to those who had retired after 1.11.1993, has been mentioned or provided.</p> <p>YOU ARE REQUESTED THAT BEFORE REPLYING TO QUERY AT POINT NO.2, IT MAY KINDLY BE NOTED CAREFULLY AND METICULOUSLY THAT FORMULA FOR CALCULATION OF THE RATES OF DR MENTIONED IN THE INSTRUCTIONS RELATED TO REGULATION 29 OF THE IFCI PENSION REGULATIONS, 1993 IS APPLICABLE ONLY TO THOSE WHO HAD RETIRED PRIOR TO 1.11.1993. NO SEPARATE FORMULA FOR CALCULATION OF THE RATES OF DR APPLICABLE TO THOSE WHO HAD RETIRED AFTER 1.11.1993 HAS BEEN PROVIDED OR MENTIONED EITHER IN</p>
