Information Sought (जानकारी मांगी):	IFCI, along with its letter No.IFCI/RTI/1262/2024-240105010 dated 05-01-2024 had provided me copies of three notings dated 08-08-2022, 15-02-2023 and 10-08-2023 by which the proposals for revision in the rates of DA relief on pension for the half years August 2022 to January 2023, February 2023 to July 2023 and August 2023 to January, 2024, respectively were approved. All the said three notings state that Rates of DA relief to pensioners are revised at half yearly intervals every year based on movement in the all India Average Consumer Price Index as computed by IBA circulars. Earlier also, vide its letter No. IFCI/HRD/Ex/2014- 1606183 dated 16.06.2014, IFCI had informed one of its former Private Secretaries, Shri J.N. Sharma, that he was being paid Dearness Relief in accordance with the circular issued by Indian Bank Association. However, from the amount of pension for the month of February, 2024 credited to my bank account, it is observed that the amount of DA paid to me for February 2024 has not been computed in accordance with circular dated 07.02.2024 of IBA through which rates of DA has been circulared for the half year February-July, 2024 (copy of IBA circular is attached). In the context of the foregoing, you are requested to provide me the following information 1. Provide me a copy of the document containing the formula based on which the rates of DA relief for the half year February to July 2024 have been calculated.

2. Provide me a copy of Calculation sheet showing the calculations for the amount of DA relief paid to me for the month of February, 2024.

3. Inform me the date of Board meeting at which the Board of Directors of IFCI have approved to dispense with or discontinue the practice of revising the rates of DA based on computation done as per the circulars of IBA.

4. Provide me a copy of Board Memo placed before the Board of Directors seeking their approval to dispense with the practice of revising the rates of DA, for the pensioners and family pensioners of IFCI, based on computation done as per the circulars of IBA.

5. Provide me a copy of HR or other policy circular whereby the decision of IFCI to dispense with or discontinue the practice of revising the rates of DA based on computation done as per the circulars of IBA, has been circulated to the pensioners and family pensioners of IFCI.

6. Provide me a copy of file noting wherein the proposal for revising the rates of DA on pension for the pensioners and family pensioners of IFCI for the half year February-July, 2024 was examined and approved by the competent authority.
