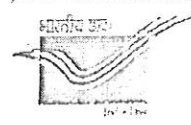

Dear Sir,

This is with reference to your letters dated September 8 & 26, 2011 requesting to treat your removal from service as normal retirement and seeking release of retiral dues.

2. It may be noted that the order of removal dated July 31, 2007 is absolute and final and no further correspondence shall be entertained with regard to the said removal. Your request to treat your removal as having retired w.e.f. July 31, 2011 is not tenable.

3. You are not entitled for pension, contributory provident fund, performance linked incentives, revised gratuity & leave encashment in terms of extant rules/regulations. Regarding LFC, it may be mentioned that the same had been availed by you from NITCON for the Block Year 2005-06.
