Text of RTI First Appeal (आरटीआई प्रथम अपील का पाठ) :	The Appeal is preferred against the disposal of my RTI Application bearing the above number. 1. The CPIO has invoked section 8 (1) (h) of the RTI Act to deny the information. This is apparently wrong, mischievous and has been invoked to suppress perhaps a very serious wrong doing by the Public Authority.

2. The public authority is required to demonstrate its intent and purpose of serving public interest . The RTI Act has been enacted with the purpose of promoting transparency and good governance in the working of Public Institutions. The CPIO has lost sight of the above objectives and denied information on very frivolous ground by Stating that no public interest would be served by the disclosure of the information.

3. The CPIO has failed to appreciate that public interest would be better served by the disclosure of the information. It has been abundantly made clear that no personal information has been sought and if any personal information is contained in the said notings, the same may be masked or redacted. The CPIO has miserably failed to apply his mind.

4. In view of the above the FAA may direct the submission of the information as the disclosure would serve the public interest , promote public good and uphold the principles of Transparency which the RTI Act seeks to Promote and achieve.
