RTI application has been declined vide letter no. IFCIL/Venture/RTI/2024-25/20105577 dated 21.06.2024. Ground for declining the information is that the information is of commercial confidence in respect of parties concerned, fiduciary in nature as held by [REDACTED] and personal in nature under sections 8(1)(d); 8(1)(e) and 8(1)(j) of RTI Act.
