Sub: RTI Application no.IFCIL/R/E/24/00027 dated 19/05/2024- FAA order dated 24/07/2024- Reply on behalf of IFCI Ltd. under the provisions of the RTI Act, 2005.

Please refer to your RTI Application which was responded to vide letter no.IFCI/RTI/1307/2024- 240610003 dated 10/06/2024 and the FAA order dated 24/07/2024 vide which the RTI Application was remanded back for reconsideration and disposal.

2. In this regard, since the RTI Application was already replied vide letter dated 10/06/2024 and the matter was remanded for reconsideration, the RTI Application was again forwarded to the Concerned Dept. for providing the comments/information by re-visiting the contents of the RTI Application. A suitable notice was also sent to the CBI on 01/08/2024 u/s 11 of the RTI Act, 2005.

3. In this regard, on the basis of the stand taken by the Concerned department acting through its HOD/Deemed CPIO being the custodian/holder of the information, the query wise response is as under:-

- i. In response to query no.1 to 4 and 5 (partially) of the application, please note that the subject matter of the information relates to the pending investigation by Central Bureau of Investigation (CBI) and as such no information qua the said queries can be provided at this stage. The said queries are disposed off, accordingly.
- ii. In response to query no. 5 (remaining) of the application, the information is sought regarding the other employees of IFCI Ltd. which is the personal information of the said employees and as such cannot be disclosed as it would cause unwarranted invasion on the privacy of the individuals. Accordingly, the said query is declined in view of Sec 8(1)(j) of the RTI Act, 2005.
