

1. In response to query no.1 & 2 of the application, please note that IFCI has carried out audits as per the extant Policies/guidelines. The said reports are confidential documents which are protected from disclosure in view of Sec 8 (1)(d) as well as 8(1) (e) of the RTI Act, 2005.
2. In response to query no.3 of the application, please note IFCI made the disbursements on 30/03/2015 and 06/06/2015 for Rs.25.00 crore each per disbursement.
3. In response to query no.4 of the application, please note that sanctioning and disbursement of loans is a commercial activity, and, in the process, various documents are received from the Borrower. Accordingly, the said information is protected from disclosure by virtue of the provisions of Sec 8(1)(d) read with Sec 8(1)(j) of the RTI Act, 2005.
4. In response to query no.5 to 8 of the application, your reference is invited to the provisions of Sec 2(1)(f) of the RTI Act, 2005 which provides that only specific information which exists on the records of the Public Authority is accessible under the act. Please note that the CPIO is not supposed to create information or interpret information or give his opinion or furnish replies to hypothetical or subjective questions. The queries are disposed off, accordingly.
5. In response to query no.9 of the application, please note that IFCI has filed Original Application (OA) before the Debt Recovery Tribunal (DRT), initiated action under SARFAESI Act and proceeding against the guarantors.
6. In response to query no.10 of the application, the query is vague and ambiguous.
