I am a retired Assistant General Manager in State Bank of India. I had invested an amount of Rs 20,000/- in the Bonds issued by you in the year 2012. As I was on mobile duty at that point of time and was on the move regularly, I did not receive the copy of the Bond. In due course, I lost the copy of the acknowledgement of the investment issued at the time of the investment and

I lost track of the investment.

In the TDS TRACES for the financial year 2023-24, I found an entry of tax deduction under Sec 193 of Rs 3,324/- made by you towards interest payment on the Bond. On scrutiny I did not find any credit of the principle and interest into my account. Incidentally I have to advise that the Bank account through which I made the investment was closed before the maturity of the Bond. Hence I request you to please trace the entry and make payment to me by means of a Bank draft.

My PAN no is AENPP 0377C.

If the amount could not be paid on the basis of this request letter, I shall be grateful if you please advise me the details of the Bond and the procedure to claim the amount.
