IND 2 926 dated 14 feb 2023. IFCI is the parent authority and SHCIL is its subsidiary company as IFCI has more than 58% share in SHCIL and IFCI is the contolling authority as the SHCIL is substancially financed by IFCI. So as per section 2(h) of RTI act IFCI has the authority to call the data and prvovide it to citizens from SHCIL. and SHCIL delhi headquarter is also situated in the IFCI building headqsrter only. So PIO of IFCI should not transfer the RTi application to SHCIL or stockholding as IFCI are contolling authority and SHCIL is substantially financed by government & IFCI. In addition to above, SHCIL has consistently taken stand in Chief information commission that they do not come under RTI act as they are
